# ELDER LAW QUICK FACTS

UPDATED JANUARY 1, 2024

## 2024 MEDICARE NUMBERS

The Centers for Medicare and Medicaid Services (CMS) has released the new Medicare premiums, deductibles, and co-payments for 2024:

<b>Basic Part B Premium</b> .....	<b>\$174.70/month</b> (was \$164.90 in 2023)
<b>Part B Deductible</b> .....	<b>\$240.00</b> (was \$226.00 in 2023)
<b>Part A Deductible</b> .....	<b>\$1,632.00</b> (was \$1,600.00 in 2023)
<b>Co-Payment for Hospital Stay Days 61-90</b> .....	<b>\$408.00/day</b> (was \$400.00 in 2023)
<b>Co-Payment for Hospital Stay Days 91-150</b> .....	<b>\$816.00/day</b> <i>All costs for each day beyond 150 days</i> (was \$800.00 in 2023)
<b>Skilled Nursing Facility Co-Payment Days 21-100</b> .....	<b>\$204.00/day</b> (was \$200.00 in 2023)

Also, individuals with annual incomes over \$103,000 and married couples with annual incomes over \$206,000 will pay a higher Medicare Part B premium, with a minimum monthly premium of \$244.60.

<b>Minimum Community Spouse Resource Allowance</b> .....	<b>\$30,828.00</b> (was \$29,724.00 in 2023)
<b>Maximum Monthly Maintenance Needs Allowance</b> .....	<b>\$3,853.50</b> (was \$3,715.50 in 2023)
<b>Minimum Monthly Maintenance Needs Allowance</b> .....	<b>\$2,465.00</b> (thru June 30, 2024)
<b>Medicaid Waiver Benefits Income Cap</b> .....	<b>\$2,829.00/month</b> (was \$2,742.00 in 2023)
<b>Pennsylvania Medicaid Penalty Divisor</b> .....	<b>\$379.65/day</b> (as of January 1, 2024)
<b>New Jersey Medicaid Penalty Divisor</b> .....	<b>\$384.57/day</b> (since April 1, 2023)
