The Centers for Medicare and Medicaid Services (CMS) has released the new Medicare premiums, deductibles, and co-payments for 2024:

Basic Part B premium:
Part B deductible:

Co-payment for hospital stay days 61-90: \$408/day (was \$400 in 2023)
Co-payment for hospital stay days 91-150: <b>\$816/day</b> (was \$800 in 2023)
All costs for each day beyond 150 days


Also, individuals with annual incomes over \$103,000 and married couples with annual incomes over \$206,000 will pay a higher Medicare Part B premium, with a minimum monthly premium of \$244.60.
