I also dream that



2021 Elder Law Numbers

2021 Medicare Numbers

The Centers for Medicare and Medicaid Services (CMS) has released the new Medicare premiums, deductibles, and co-payments for 2021:

Basic Part B premium:
Part B deductible:

Co-payment for hospital stay days 61-90: \$371.00/day (was \$352.00 in 2020);
Co-payment for hospital stay days 91-150: \$742.00/day (was \$704.00 in 2020)
All costs for each day beyond 150 days

Also, note that individuals with annual incomes over \$88,000 and married couples with annual incomes over \$176,000 will pay a higher Medicare Part B premium, with a minimum monthly premium of \$207.90.


