2024 MEDICARE NUMBERS

The Centers for Medicare and Medicaid Services (CMS) has released the new Medicare premiums, deductibles, and co-payments for 2024:

Basic Part B Premium	\$174.70/month (was \$164.90 in 2023)
Part B Deductible	\$240.00 (was \$226.00 in 2023)
Part A Deductible	\$1,632.00 (was \$1,600.00 in 2023)
Co-Payment for Hospital Stay Days 61-90	\$408.00/day (was \$400.00 in 2023)
Co-Payment for Hospital Stay Days 91-150	\$816.00/day <i>All costs for each day beyond 150 days</i> (was \$800.00 in 2023)
Skilled Nursing Facility Co-Payment Days 21-100	\$204.00/day (was \$200.00 in 2023)

Also, individuals with annual incomes over \$103,000 and married couples with annual incomes over \$206,000 will pay a higher Medicare Part B premium, with a minimum monthly premium of \$244.60.

Minimum Monthly Maintenance Needs Allowance	\$2,465.00 (thru June 30, 2024)
Medicaid Waiver Benefits Income Cap	\$2,829.00/month (was \$2,742.00 in 2023)
Pennsylvania Medicaid Penalty Divisor	\$379.65/day (as of January 1, 2024)
New Jersey Medicaid Penalty Divisor	\$440.10/day (since April 1, 2024)
