# Voting Information for Residents and Long-Term Care Facilities

Election season is an exciting time that offers a renewed opportunity to shape public policy. If you live in a nursing home, federal nursing home regulations emphasize that you have the same rights as any other citizen of the United States – this includes your right to vote!

### **Federal laws state that:**

- All aspects of voter registration must be accessible to people with disabilities.
- Voters with disabilities can receive assistance from a person of their choice.
- Polling places must be accessible and if they are not, voters must be provided with an alternative means to vote on election day.

Long-term care facilities should have a plan to ensure residents can exercise their right to vote. This could include providing direct support to residents and/or coordinating with state programs that provide assistance to those living in residential facilities. However, you should have a plan for voting too.

Consider the following when creating your plan:

Options for voting may include:

- 1) Absentee ballot
- 2) Mail-in voting
- 3) Early voting
- 4) Voting in person on Election Day

Assistance with registering to vote, requesting an absentee ballot,

or filling out your ballot, can be obtained from a person of your choice, including a family member, a staff person, or someone else. Residents should be able to choose the method of voting that they prefer and that is easiest for them.

Nursing homes are required to support you in exercising your right to vote, this means they should:

- 1) Reach out and ask residents about voting and help any resident who expresses a desire to vote. Ensure the staff does not make their own determinations about who is eligible to vote.
- 2) Support you in obtaining assistance to vote if needed.
- 3) Assist with voter identification requirements, including helping you obtain an acceptable form of identification if necessary.
- 4) Help you determine if you are registered to vote, and your voter registration is up to date, including with the correct address.
- 5) Provide and assist with your mail in voting or
  - absentee ballot request forms and ballots if you are not planning to vote in person.
  - 6) Provide stamps, envelopes, and other materials you may need if you're submitting a mail-in or absentee ballot.
  - 7) Arrange transportation to your polling sites if you choose to vote in person.

documents and financial needs. We now are privileged to have eight elder care coordinators on our team. At Rothkoff Law Group, care comes first, then we design an asset protection plan. ## Be Prepared for Medicare's Annual Enrollment Period

The Medicare Open Enrollment Period for 2025 will arrive shortly. Throughout the year, Medicare has different enrollment periods. The Open Enrollment Period, or OEP, is the timeframe during which Medicare beneficiaries can make changes to their Medicare plans.

This year's OEP will take place October 15 through December 7, 2024. Any changes you make to your Medicare plan during this period go into effect on January 1, 2025.

During OEP, you can...

- Switch from Original Medicare (Medicare Parts A and B) to a Medicare Advantage (Medicare Part C) plan.
- Switch from a Medicare Advantage plan back to Original Medicare.
- Switch from one Medicare Advantage plan to another. This might involve switching from a plan without Medicare Part D prescription drug coverage to one that has it, or vice-versa.
- Make changes to your Medicare Part D prescription drug plan:
  - Join a Part D plan.
  - Switch from one Part D plan to another one.
  - Drop your Part D plan altogether.

*Note:* Medicare Supplement Insurance plans are an exception. You can join one at any time during the year, not just during OEP.

Once the Medicare Open Enrollment Period closes on December 7, 2024, you cannot make any changes to your Medicare plan until the following year. There are some exceptions, such as if you move out of the area served by your plan. But for most people on Medicare, the OEP is the only time when you can make a change.

Please note if the Medicare coverage you have now is working for you, and your plan(s) is offered for 2025, then you can keep your coverage as it is. However, because this time comes but once a year, it is a good idea to evaluate your coverage during Open Enrollment Period every year. That way, you will know if you already have the best coverage options for you, or if you need to make some changes. Be sure to make the decisions that will best meet your health care coverage needs for the coming year. Your status in October may not be where you find yourself next July.
