ELDER LAW QUICK FACTS

UPDATED JANUARY 1, 2025

2025 MEDICARE NUMBERS

The Centers for Medicare and Medicaid Services (CMS) has released the new Medicare premiums, deductibles, and co-payments for 2025:

Basic Part B Premium	\$185.00/month (increase of \$10.60 from 2024)
Part B Deductible	\$257.00 (increase of \$17.00 from 2024)
Part A Deductible	\$1,676.00 (increase of \$44.00 from 2024)
Co-Payment for Hospital Stay Days 61-90	\$419.00/day (increase of \$11.00 from 2024)
Co-Payment for Hospital Stay Days 91-150	\$838.00/day (increase of \$22.00 from 2024)
<i>All costs for each day beyond 150 days</i>	
Skilled Nursing Facility Co-Payment Days 21-100	\$209.50/day (increase of \$5.50 from 2024)

Also, individuals with annual incomes over \$106,000 and married couples with annual incomes over \$212,000 will pay a higher Medicare Part B premium, with a minimum monthly premium of \$244.60.

Minimum Community Spouse Resource Allowance	\$31,584.00 (increase of \$756.00 from 2024)
Maximum Monthly Maintenance Needs Allowance	\$3,948.00 (increase of \$94.50 from 2024)
Minimum Monthly Maintenance Needs Allowance	\$2,555.00 (thru June 30, 2025)
Medicaid Waiver Benefits Income Cap	\$2,901.00/month (increase of \$72.00 from 2024)
Pennsylvania Medicaid Penalty Divisor	\$399.80/day (as of January 1, 2025)
New Jersey Medicaid Penalty Divisor	\$440.10/day (since April 1, 2024)
